### **Refund Rules on cancellation of admission for MBA, MBA HR - Mumbai & PGDM Programme - Navi Mumbai Campus**

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following four-tier system for the refund of fees remitted by the student.

<b>Sr. No.</b>	<b>Percentage of Refund of Aggregate fees*</b>	<b>Point of time when notice of withdrawal of admission is served to the Institute</b>
1	100%	15 days before the formally-notified last date of admission ( <b>on or before 4<sup>th</sup> June 2018</b> )
2	80%	Not more than 15 days after the formally-notified last date of admission ( <b>5<sup>th</sup> June to 5<sup>th</sup> July 2018</b> )
3	50%	More than 15 days but less than 30 days after formally-notified last date of admission ( <b>6<sup>th</sup> July to 20<sup>th</sup> July 2018</b> )
4	00%	More than 30 days after formally-notified last date of admission ( <b>21<sup>st</sup> July 2018 onwards</b> )

2	80%	Not more than 15 days after the formally-notified last date of admission ( <b>7<sup>th</sup> June to 7<sup>th</sup> July 2018</b> )
3	50%	More than 15 days but less than 30 days after formally-notified last date of admission ( <b>8<sup>th</sup> July to 22<sup>nd</sup> July 2018</b> )
4	00%	More than 30 days after formally-notified last date of admission ( <b>23<sup>rd</sup> July 2018 onwards</b> )
