**Refund Rules on cancellation of admission:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following four-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to Higher Educational Institution (HEI)
1	100%	15 days before the formally-notified last date of admission ( <b>on or before 4<sup>th</sup> June 2018</b> )
2	80%	Not more than 15 days after the formally-notified last date of admission ( <b>5<sup>th</sup> June to 5<sup>th</sup> July 2018</b> )
3	50%	More than 15 days but less than 30 days after formally-notified last date of admission ( <b>6<sup>th</sup> July to 20<sup>th</sup> July 2018</b> )
4	00%	More than 30 days after formally-notified last date of admission ( <b>21<sup>th</sup> July 2018 onwards</b> )

In case of (1) in the table above, the deduction will be 10% of the aggregate fees as processing charges from the refundable amount. Aggregate fees is inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit.
